Insured amount: The insurance must cover medical fees and repatriation costs up to 30.000 Euro (around 300.000 RMB), and the cost of out-patient and in-patient in your travel insurance must be up to 30.000 Euro.</p> <p>Purchase full insurance coverage for the Schengen area directly at the Visa Application Centre! 8	<p>Bank statement of the applicant covering the last three months (except credit card record or deposits account), original</p> <p>For minor or unemployed applicant, you can also provide the bank statement of your parents or spouse.</p>	Y	
9	<p>Hukou, copy</p> <p>Copies of the whole hukou (family booklet). Only required for Chinese citizen.</p>		Y
10	<p>Passport, original</p> <p>A full national private passport or official travel document. For more information on passport standard, please refer to FAQ section of our website.</p> <p>Before submitting your application, please check the following:</p> <p>1. Passport validity:</p> <ul style="list-style-type: none"> - your passport should be issued less than 10 years. - For a short-stay Schengen visa (less than 90 days): expiration date must be no earlier than 3 months after the date of your return from the Schengen Area. - For Renewal of a circulation visa: expiration date must be 15 months after the day of visa application. - For a regular long stay visa (more than 90 days): expiration date must be 15 months after the scheduled departure day from China. <p>2. Your passport should contain two blank visa pages.</p> <p>3. Make sure your passport has not been altered or damaged. If your passport is damaged or validity is not sufficient, you must renew or change your passport.</p> <p>4. If you have obtained a Schengen visa with VIS remark issued within the past 59 months, you may entrust a representative to submit your visa application at visa centre. For detailed requirements for exemption of biometric enrolment, please refer to FAQ section of our website.

11	<p><u>Letter of authorization for visa application/passport return, original</u></p> <p>Mandatory if you choose to submit your application by a representative. Please download the standard template from our website. Other format is not accepted.</p> <p>1. The signature on the letter of authorization must be identical as the signature on applicant’s passport and visa application form. The form has to be filled out completely. No alteration is accepted.</p> <p>2. The letter can’t be sharable and each applicant has to present one original letter.</p> <p>3. Minor applicant (under the age of 18 on submission day): This letter must be signed by one parent or a legal guardian. An adult is authorized to accompany the underage applicant for the submission and enrollment of biometric data (Parents’ ID photocopies should be joined with the authorization letter). Please DO NOT sign the name of underage applicant.</p> <p>Please note that: (1) The authorization letter must be signed by a legal guardian. The representative is not authorized to sign it. (2) Personal appearance is not required for children under 12 years old. If a parent submit the application for his/her minor child, the authorization is not required. In this case, he/she must provide clear family relation proofs.</p>	Y
