Minor applicant under the age of 18: The letter of authorization must be signed by one parent or a legal guardian: An adult is authorized to accompany the underage applicant for the submission and enrollment of biometric data (Parents' ID photocopies should be joined with the authorization letter) Please DO NOT sign the name of the underage applicant.		
Please note that:		
(1) The authorization letter must be signed by a legal guardian. The representative is not authorized to sign it.		
(2) Personal appearance is not required for children under 12 years old.		
The age on the date of application submission is taken as reference to determine if an applicant is a minor or not.		
The authorization is not required, if parents submit the application for their minor-aged children. However, they should provide evidence proving the family relation (such as hukou etc.).
