	<p><b>Short stay Schengen application form</b></p> <p>The applicant should fill out the form which can be found <a href="#">here</a>. The application form can also be filled out online and printed out after the registration process.</p> <p><b>Notes:</b></p> <p>1. Language: The form must be filled out in English or in French.            2. Signature: The Schengen application form has to be signed by the applicant. The signature of a representative is invalid.            1) The signature on the form should be similar to the one on the applicant’s passport and letter of representation.            2) Please sign in the column No. 37 and the last column.            3) <b>Minor applicant under the age of 18: The application form must be signed by one parent or a legal guardian. Please DO NOT sign the name of underage applicant.</b>            Please indicate “father”/”mother”/”guardian” beside signature. The signature of a representative is invalid.</p> <p>2) Please indicate day and location, and <b>sign in the last field of last page.</b></p> <p>3) <b>Minor applicant (under the age of 18 on application submission day):</b>  <b>The form must be signed by one parent or a legal guardian. Please DO NOT sign the name of underage applicant. Whenever possible, both parents are strongly advised to sign on the form. Please indicate "father"/"mother"/"guardian" beside signature.</b></p>			
<b>Mandatory for foreigners</b>	<p><b>Chinese residence permit</b></p> <p>A foreign applicant must hold a residence permit with a period of validity of no less than 6 months or a permanent residence card. <b>For minors (&lt; 18 years old)</b>	<b>Notarial certificate of parental authority delegation certified by the Chinese Ministry Of Foreign Affairs or by the Chinese Embassy, original containing translation</b>  For foreigners: Notarial certificate of parental authority delegation certified by the Embassy/Consulate of your country in China, original containing translation  This document should contain the parents' signature and should define the person in charge for the underage in Schengen area. Mandatory if the child is traveling alone or with only one of the parents.	Y	Y	
<b>If child &gt; 18 years old</b>	<b>Proof of financial dependence of the child</b>	Y		
	<b>Insurance, original</b>  1. The travel insurance should be: <ul style="list-style-type: none"> <li>• Valid for Schengen area if you apply for short stay visa</li> <li>• Valid for France if it's required in the document list and you apply for long stay visa</li> <li>• Valid for DROM/CTOM according to your itinerary</li> </ul> 2. The insurance must cover medical fees and repatriation costs up to 30.000 Euro (around 300.000 RMB), and the cost of out-patient and in-patient in your travel insurance must be up to 30.000 Euro. 3. The insurance coverage should cover the first period of your stay in Schengen area. (This point does not remove the requirement of the obligation of presenting an insurance for subsequent trips, as the periods indicated on application form). 	<p><b>Convention d’Accueil</b></p> <p>This document must be signed and stamped by inviting organization indicating the purpose and duration of stay in France.</p>		Y	
	<p><b>Passport</b></p> <p>A full national private passport or official travel document valid for at least more than 3 months beyond the validity of the requested visa, with two blank visa pages with the mention “visa” to affix the visa sticker. Should be issued less than 10 years ago. For more information please visit “Passport Validity” on FAQ page.</p> <p>Copies of the first 5 pages of the passport containing information, and all pages that contain visas or stamps.</p>	Y	Y	
	<p><b>Previous passports</b></p> <p>If you are in possession of one or more previous passports, it is mandatory to provide them.</p> <p>Copies of the first 5 pages of every previous passport, and all the pages that contain visas or stamps.</p>	Y	Y	
	<p><b>Letter of authorization for visa application/passport return</b></p> <p>Mandatory if you choose to submit your application by a representative.  <a href="#">Download.</a></p> <p><b>Requirements:</b></p> <p><b>1. The signature on the letter of authorization needs to be the same as the one in the applicant’s passport and Visa application form. The form has to be filled out completely. No correction is allowed on the form.</b></p> <p><b>2. The letter can’t be shared and each applicant has to present the original.</b></p> <p><b>3. Minor applicant under the age of 18: The letter of authorization must be signed by one parent or a legal guardian: An adult is authorized to accompany the underage applicant for</b></p>	Y

	<p>the submission and enrolment of biometric data (Parents' ID photocopies should be joined with the authorization letter) Please <b>DO NOT</b> sign the name of the underage applicant.</p> <p>Please note that:</p> <p><b>(1) The authorization letter must be signed by a legal guardian. The representative is not authorized to sign it.</b></p> <p><b>(2) Personal appearance is not required for children under 12 years old.</b></p> <p>The age on the date of application submission is taken as reference to determine if an applicant is a minor or not.</p> <p>The authorization is not required, if parents submit the application for their minor-aged children. However, they should provide evidence proving the family relation (such as hukou etc.).</p>
