SHORT STAY – TRANSIT VISA - BEIJING/GUANGZHOU/SHENYANG/WUHAN

The **Transit Visa** (Type C short stay visa) allows you to transit in France or in the Schengen Area for a maximum of five days before your departure for your final destination. This visa does give you the right to leave the international airport zone. If you are not intending on leaving the international zone, depending on the citizenship of the passport you are bearing, you might still need to apply for an Airport Transit visa.

You must provide the flight ticket booking (full trip or round-trip ticket reservation with confirmed date) and a hotel booking (if your stay is longer than 24 hours).

If employed or self-employed	Working certificate Original letter from employer on official company paper with stamp, signature, date and clearly mentioning: address, telephone and fax numbers of the company; the name and position in the company of the countersigning officer; the name of the applicant, position, salary and years of service; confirmation of position after the return; the purpose of the visit; the person or the entity who will bear your travel and living costs and approval for leave or absence. The insurance must cover medical fees and repatriation costs up to 30.000 Euro (around 300.000 RMB), and the cost of out-patient and in-patient in your travel insurance must be up to 30.000 Euro. Should be issued less than 10 years ago. 	<p>Previous passports</p> <p>If you are in possession of one or more previous passports, it is mandatory to provide them.</p> <p>Copies of the first 5 pages of every previous passport, and all the pages that contain visas or stamps.</p>	Y	Y
	<p>Visa or travel document valid for the main destination</p> <p>If a visa is needed for the country of your final destination, you are required to obtain it prior to this application.</p>	Y	Y
	<p>Letter of authorization for visa application/passport return</p> <p>Mandatory if you choose to submit your application by a representative. Download.</p> <p>Requirements:</p> <p>1. The signature on the letter of authorization needs to be the same as the one in the applicant’s passport and Visa application form. The form has to be filled out completely. No correction is allowed on the form.</p> <p>2. The letter can’t be shared and each applicant has to present the original.</p> <p>3. The representative is not authorized to sign it.</p> <p>(2) Personal appearance is not required for children under 12 years old.</p> <p>The age on the date of application submission is taken as reference to determine if an applicant is a minor or not.</p> <p>The authorization is not required, if parents submit the application for their minor-aged children. However, they should provide evidence proving the family relation (such as hukou etc.).</p>
