SHORT STAY - TRANSIT VISA - BEIJING/GUANGZHOU/SHENYANG/WUHAN

The **Transit Visa** (Type C short stay visa) allows you to transit in France or in the Schengen Area for a maximum of five days before your departure for your final destination. This visa does give you the right to leave the international airport zone. If you are not intending on leaving the international zone, depending on the citizenship of the passport you are bearing, you might still need to apply for an Airport Transit visa.

You must provide the flight ticket booking (full trip or round-trip ticket reservation with confirmed date) and a hotel booking (if your stay is longer than 24 hours).



authorized to accompany the underage applicant for the submission and enrollment of biometric data (Parents' ID photocopies should be joined with the authorization letter) Please DO NOT sign the name of the underage applicant.

Please note that:

- (1) The authorization letter must be signed by a legal guardian. The representative is not authorized to sign it.
- (2) Personal appearance is not required for children under 12 years old.

The age on the date of application submission is taken as reference to determine if an applicant is a minor or not.

The authorization is not required, if parents submit the application for their minor-aged children. However, they should provide evidence proving the family relation (such as hukou etc.).

Representative's ID Card or passport

Mandatory if you choose to submit your application by a representative.
