	 Language: The form must be filled out in English or in French. Signature: The Schengen application form has to be signed by the applicant. The signature of a representative is invalid. The signature on the form should be similar to the one on the applicant's passport and letter of representation. 	Υ	
	 2) Please sign in the column No. 37 and the last column. 3) Minor applicant under the age of 18: The application form must be signed by one parent or a legal guardian. Please DO NOT sign the name of underage applicant. 		
	Please indicate "father"/"mother"/"guardian" beside signature. Whenever possible, we suggest that both parents sign on the form.		
	Chinese residence permit		十
Mandatory for foreigners	A foreign applicant must hold a residence permit with a period of validity of no less than 6 months or a permanent residence card. Holders of a single-entry or a multi-entries visa are not allowed to apply for any visa except for airport transit visa.		





	Studies certificate or diploma		
For students and minors	Should be issued by your school to precise your grade and how many days school permit your leave. Should include school's address, contact and official seal. Should also indicate name, position and signature of the person in charge.	Y	Y
For minors	Notarial certificate of birth OR notarial certificate of family relationship between parents / legal guardian and the minor applicant. All these acts must be legalized by the Chinese Ministry of Foreign Affairs, the Chinese Embassy or the Waiban, original containing translation in English or in French		Y
(< 18 years old)	For foreigners: Notarial certificate of Medical Certificate of Birth, legalized by the Embassy/Consulate of your country in China, original containing translation	ľ	Y
	Notarial certificate of parental authority delegation certified by the Chinese Ministry Of Foreign Affairs or by the Chinese Embassy, original containing translation		
For minors (< 18 years old)	For foreigners: Notarial certificate of parental authority delegation certified by the Embassy/Consulate of your country in China, original containing translation	Y	Y
	This document should contain the parents' signature and should define the person in charge for the underage in Schengen area. Mandatory if the child is traveling alone or with only one of the parents.		
	Invitation letter		
	Invitation letter from the inviting company or the host in France specifying: duration of the envisaged stay, the goal of the stay, the financial support as well as the detailed program. The letter should be hand-signed by host party.	Y

	A full national private passport or official travel document valid for at least more than 3 months beyond the validity of the requested visa, with two blank visa pages with the mention "visa" to affix the visa sticker. Should be issued less than 10 years ago. More information on FAQ page on our website.	Y	Υ
	Copies of the first 5 pages of the passport containing information, and all pages that contain visas or stamps.		





Previous passports

If you are in possession of one or more previous passports, it is mandatory to provide them.

Copies of the first 5 pages of every previous passport, and all the pages that contain visas or stamps.

Letter of authorization for visa application/passport return

Mandatory if you choose to submit your application by a representative. Download.

Requirements:

- 1. The signature on the letter of authorization needs to be the same as the one in the applicant's passport and Visa application form. The form has to be filled out completely. No correction is allowed on the form.
- 2. The letter can't be shared and each applicant has to present the original.
- 3. Minor applicant under the age of 18: The letter of authorization must be signed by one parent or a legal guardian: An adult is authorized to accompany the underage applicant for the submission and enrollment of biometric data (Parents' ID photocopies should be joined with the authorization letter) Please DO NOT sign the name of the underage applicant.

Please note that:

- (1) The authorization letter must be signed by a legal guardian. The representative is not authorized to sign it.
- (2) Personal appearance is not required for children under 12 years old. The age on the date of application submission is taken as reference to determine if an applicant is a minor or not.

The authorization is not required, if parents submit the application for their minor-aged children. However, they should provide evidence proving the family relation (such as hukou etc.).

Representative's ID Card or passport

Mandatory if you choose to submit your application by a representative.
