

1	<p><b>One recent identity photo</b>            Size 3.5 cm x 4.5 cm, color photo with white background, mouth closed, taken within 6 months and from the front without any head-coverings. Please refer to "Visa photo" of FAQ section of this website.</p>
2	<p><b>Short stay Schengen application form</b>  <b>Notes:</b>            1. <b>Template of application form:</b> The applicant may download form from "Links and Downloads" on this website.  <b>If your destination is France mainland, please download Short-stay Schengen visa application form.</b>  <b>If your destination is France DROM-CTOM, please download DROM-CTOM visa application form.</b>            2. <b>Language:</b> The form must be filled out in <b>English</b> or in <b>French</b>.            3. <b>Signature:</b>            1) The form must be signed by adult applicant of 18 years old and above. It must match the signature on the passport. The signature of a representative is invalid.            2) Please indicate day and location, and <b>sign in the last field of last page.</b>            3) <b>Minor applicant (under the age of 18 on application submission day):</b>  <u>The form must be signed by one parent or a legal guardian. Please DO NOT sign the name of underage applicant. Whenever possible, both parents are strongly advised to sign on the form.</u>  <b>Please indicate "father"/"mother"/"guardian" beside signature.</b></p>
3	<p><b>Round-trip flight ticket booking from China to France, copy</b>            1. If your booking document is in Chinese, please translate the key information in English or French, including applicant's name, departure city, destination, departure and arrival dates, etc.            2. If you will visit another Schengen country before or after travelling to France, please provide also the relevant travel documents: round-trip flight booking from China to another country, flight, train</p>





4	<p><b>Insurance, original and copy</b></p> <p><b>1. Insurance coverage:</b></p> <p>1) The insurance policy should indicate clearly its validity for <b>whole Schengen area</b>. The insurance covering France only is not compliant.</p> <p>2) If the travel insurance policy doesn't indicate Schengen area and the zones covered by insurance are shown in the clauses, please also provide the photocopies of insurance clauses (English or French translation required, if the policy is in Chinese).</p> <p><b>2. Insurance period:</b></p> <ul style="list-style-type: none"> <li>• <b>Short-stay Schengen Visa (less than 90 days):</b> The insurance should cover the 1st planned stay in Schengen area, from the arrival day to the first Schengen country till the departure day from the last Schengen country, matching air ticket booking.</li> <li>• <b>Short-stay Visa for DROM/CTOM (less than 90 days):</b> The insurance should cover the whole period of your stay in DROM/CTOM.</li> </ul> <p><b>3. Insured amount:</b></p> <p>The insurance must cover medical fees and repatriation costs up to <b>30.000 Euro</b> (around 300.000 RMB). Purchase full insurance coverage for the Schengen area directly at the Visa Application Centre! Just ask the staff in our center how to purchase one. 5	<p><b>Lodging attestation, original and copy/Hotel booking, copy</b></p> <p>Please provide a lodging attestation matching the below requirements:</p> <p>1. Original Attestation d'accueil (refer to "<a href="#">form</a>" to view model on this website) issued by the local town hall of host person's residence, in case that your host in France will provide accommodations for you. In case that your French host is not resident in France, please provide a handwriting lodging letter from the host and housing proof (lease contract or house property license) instead of attestation d'accueil.</p> <p>* In case of missing original Attestation d'accueil, please prepare two copies. Please notice that the copy can't replace the original, the original is mandatory.</p> <p>2. or copies of your hotel booking covering the whole period of your stay in Schengen area (<a href="#">refer to "Schengen area" of FAQ section</a>).</p> <p>3. or copies of your house property license or lease contract in France.</p>
6	<b>French marriage certificate of parents who reside in France, copy</b>
7	<b>French spouse's ID card, copy</b>
8	<p><b>Invitation letter, original</b></p> <p>Invitation letter from the host in France specifying: duration of the envisaged stay, the goal of the stay, the financial support as well as the detailed program. The letter should be hand-signed by host party.</p>
9	<b>Host relative passport, copy</b>

	Mandatory if the host person is foreigner resident in France, but no need if host is French. For family visit, it is mandatory for both, whether the host person is French or foreigner.
10	<p><b>Host financial guarantees, copy</b>  Original financial guaranty by the sponsor  If the sponsor lives in France: Proof of a regular income over the last 3 months, or a declaration of guarantee as provided for by France’s national legislation.  If the sponsor lives in China but invites the applicant to travel together to France: signed guarantee letter, copy of the residence permit for China, proof of a regular income (letter employer), proof of a residence in France or invitation to stay with close family  *optional if the applicant is in charge of the travel cost</p>
11	<p><b>Bank statement of the applicant covering the last three months (except credit card record or deposits account), original</b>  For minor or unemployed applicant, you can also provide the bank statement of your parents or spouse. Please indicate your relations (father, mother or husband, wife etc.) beside the name on bank statement. Also you need to provide <b>relationship proof</b> (for example: hukou, birth certificate, marriage certificate, etc.). Supporting documents should be translated in English or French.</p>
12	<p><b>Hukou, copy</b>  Copies of the whole hukou (family booklet). Only required for Chinese citizen.</p>
13	<p><b>Passport, original</b>  A full national private passport or official travel document. For more information on passport standard, please refer to FAQ section of our website.  Before submitting your application, please check the following:  <b>1. Passport validity :</b>  - your passport should be issued less than 10 years.  - For a short-stay Schengen visa (less than 90 days): expiration date must be no earlier than 3 months after the date of your return from the Schengen Area.  - For Renewal of a circulation visa: expiration date must be 15 months after the day of visa application.  - For a regular long stay visa (more than 90 days): expiration date must be 15 months after the scheduled departure day from China.  2. Your passport should contain two blank visa pages.  3. Make sure your passport has not been altered or damaged.  If your passport is damaged or validity is not sufficient, you must renew or change your passport.  4. Signature on the last page of non-bio passport is required.  <b>Passport, copy</b>  1. Copies of the first 5 pages of the passport containing information, and all the visa pages containing visas or stamps.  2. If you hold the old passport or service passport, you are suggested to present them or at least the copies of all the visa pages containing visas or stamps.</p>

If you have obtained a Schengen visa with VIS remark issued within the past 59 months, you may entrust a representative to submit your visa application at visa center. For detailed requirements for exemption of biometric enrolment, please refer to FAQ section of our website.

14	<p><b>Letter of authorization for visa application/passport return, original</b>  <b>Mandatory if you choose to submit your application by a representative. Please download the standard template from our website. Other format is not accepted.</b></p> <p>1. The signature on the letter of authorization must be identical as the signature on applicant's passport and visa application form. The form has to be filled out completely. No alteration is accepted.</p> <p><b>2. The letter can't be sharable and each applicant has to present one original letter.</b></p> <p>3. Minor applicant (under the age of 18 on submission day): This letter must be signed by one parent or a legal guardian. An adult is authorized to accompany the underage applicant for the submission and enrollment of biometric data (Parents' ID photocopies should be joined with the authorization letter). <u>Please DO NOT sign the name of underage applicant.</u></p> <p>Please note that:</p> <p>(1) The authorization letter must be signed by a legal guardian. The representative is not authorized to sign it.</p> <p>(2) Personal appearance is not required for children under 12 years old.</p> <p>If a parent submit the application for his/her minor child, the authorization is not required. In this case, he/she must provide clear family relation proofs.</p>



	<p>Mandatory document for minor applicant of Chinese nationality (under 18 years old on submission day).</p> <p>Please note that any required original notarial certificates submitted will not be returned to applicants.</p> <p>Procedure: please apply for a notarial certificate at a notary office, and then have it legalized by the Chinese Ministry of Foreign Affairs (MFA) or the Chinese Embassy or Provincial foreign affairs bureau (waiban). For more information on jurisdiction, procedure or required documents, please contact the competent authorities.</p> <p><b>Please note that any required original notarial certificates submitted will not be returned to applicants.</b></p>
19	<p><b>Notarial certificate of permission to travel from both parents</b> or legal guardians, legalised by the Ministry of Foreign Affairs, original containing translation in English or in French</p> <p>1. This document is mandatory when the minor (under the age of 18 years on the day of visa application submission) is travelling alone or only with one parent.</p> <p><b>2. Procedure: please apply for a notarial certificate at a notary office, and then have it legalized by the Chinese Ministry of Foreign Affairs (MFA) or the Chinese Embassy or Provincial foreign affairs bureau. For more information on jurisdiction, procedure or required documents, please contact the competent authorities.</b></p> <p><b>3. When the document is not issued in China, please provide the certificate of permission attested by the relevant authorities in the parents'/legal guardians' country of residence.</b></p> <p>4. Please note that any required original legalized notarial certificates will not be returned to applicants.</p>
<b>Foreign applicant living in China: the following documents No.20-22 are required.</b>	
20	<p><b>Chinese residence permit, original and copy</b></p> <p>A foreign applicant must hold a residence permit with a period of validity of no less than 6 months or a permanent residence card. The residence permit shall be valid after the return of applicant to China.</p> <p>Holders of a single-entry or a multi-entries visa are not allowed to apply for any visa except for airport transit visa.</p>
21	<p><b>Notary Birth Certificate or proof of guardianship, legalized by the Embassy/Consulate of your country in China, original containing translation in English or French</b>  <b>[mandatory for minor applicant of non-Chinese nationality]</b></p>
22	<p><b>Certificate of permission to travel from both parents</b> or legal guardians, original containing translation in English or in French</p> <p>This document is mandatory when the minor (under the age of 18 years on the day of visa application submission) is travelling alone or only with one parent.</p> <p>It should contain both parents' or legal guardians' signatures and should clearly state the person in charge for the underage in Schengen area.</p>
