

Checklist for FAMILY REUNION (Art. 10 – Unlimited residence permit)

Foreigners of third countries who want to reunite with foreigners of third countries (non-EU) who have the right to stay in Belgium for an unlimited period

It is essential that your file contain the following:

The original documents, plus two (2) photocopies of **each** documents.

The originals will be returned along with the passport.

- A valid passport + copy :
 - should have been issued within the previous 10 years
 - should be valid at least 3 months after the intended date of departure from the Schengen territory or, in the case of several visits, after the last intended date of departure;
 - should contain at least 2 empty pages when applying for the visa.
- please provide one copy of the passport (the empty pages don't need to be copied).
- for foreigners: copy of temporary residence card (if any) or of your residence permit.

Application forms

- **Two** application forms fully filled in, signed (two times: at the point nr. 37 **AND** on the last page!) and dated by the applicant.

Photo

- Three passport photos not older than 6 months

Contribution fees

- The proof of payment has to be submitted along with the application at the time of the application. If this is not the case, the visa application is not admissible.

Proof of relationship

- Copy of the ID Card/residence permit AND passport of the person to be joined in Belgium
 - Spouse:
 - Your marriage certificate: i.e. a true certified copy in the notarized and legalized form
 - Your notarized and legalized birth certificate mentioning the name of both parents
 - In case of divorce or widowhood: your notarized and legalized certificate of divorce / death of spouse.
 - Children under 18:
 - A notarized and legalized birth certificate mentioning the name of both parents
 - In case the parents are divorced: a true certified, notarized and legalized, copy of the divorce decision mentioning to whom of the parents the full guardianship was entrusted, together with a notarized and legalized authorization from the parent, stating that the child can permanently leave with a copy of the parent ID.
 - If travelling alone or without one of the parents : a legalized parental authorization with a copy of the parent(s) ID.
 - In case the child was adopted: a notarized and legalized adoption certificate.
 - In case a parent has deceased: a notarized and legalized death certificate of the deceased parent.

Medical certificate

- A medical certificate attesting that you are not carrying any of the diseases which might endanger public health. This certificate must be no older than 6 months from the date of issuance. The specific form must be signed and stamped by one of the Embassy's agreed physicians : <http://egypt.diplomatie.belgium.be/en/travel-to-belgium/visa/general-information/agreed-physicians>

Non-criminal record certificate

- A notarized and legalized certificate attesting to the lack of any convictions for crimes or offences under common law, together with a translation.

This certificate must be no older than 6 months from date of issuance

Sufficient accommodation

Proof that the party being joined has sufficient accommodation.

This evidence can be done either, by a copy of the property's title assigned to his principal residence housing, or by a copy of a **registered lease contract** concerning housing assigned to his principal residence. (Preferably, this document should be accompanied by an inventory of fixture (between landlord and tenant) of the leased property)

Solvency of the person to be joined

- Proof that the person being joined has stable, regular and sufficient means of subsistence during the last **12** months to meet his own needs and those of the members of his family and avoid them becoming a burden on the public authorities.

Mutual Insurance Company

- Proof that the person to be joined is affiliated to a Mutual Insurance Company (Mutualiteit / Mutualité) covering the risks for himself/herself and the members of his/her family.

NOTE

Applicants, who cannot enclose all documents from the list, should consider adding alternatives or making an explanation about the reason for not handing them in.

Our Consulate may in justified individual cases, request additional documents during the examination of an application which are not mentioned in the above harmonized list. The applicant is hereby informed that submitting the above-mentioned documents does not guarantee automatic issuance of a visa.

The documents drawn up abroad in a language other than Dutch, French or German are to be translated in accordance with the original by a sworn translator. **The translation must be legalized as a separate document in line with the procedure laid down in the country of origin, and then by the competent Belgian consulate or Embassy.**

Egyptian notarized certificates have to be authenticated by the relevant Foreign Affairs Bureau of your province before being authenticated by the Embassy / Consulate General of Belgium. They should not be older than six months.
