# **COHABITATION WITH AN EU CITIZEN**

### Cohabitation with an EU citizen (more than 90 days)

All documents submitted must be in English, French, Dutch or German. The foreign official documents must be legalised or carry an apostil, unless an exemption is provided in a treaty.

All the relevant information on this formality is available on the website of the <u>SPF Foreign Affairs</u>. For further information please click here.

**Please note** that you will need two separate and identical sets of documents (if documents are double sided, make sure you provide the photocopy of both sides).

The decision will be taken by the Immigration Office in Belgium, which can take time. Please refer to the processing time page on our Website to find all the information.

### **MANDATORY DOCUMENTS**

#### □ Two duly completed and both signed VisaOnWeb application forms (Signed copy)

• The VisaOnWeb form with the bar code is available once the registration via <u>VisaOnWeb</u> is completed. Please note that will be the only application form accepted

#### $\Box$ Four (4) ID photos meeting the ICAO standards

- Attached with a paper clip;
- In color;
- Size 3.5cm X 4.5cm;
- White plain background;
- Less than 3 months old.

#### □ Passport (Original, Copy)

- A travel document where a visa can be issued with a minimum validity of 12 months (e.g.: a passport);
- With at least 2 blank pages side by side;
- Not older than 10 years old from the first issue date.

#### □ Passport bio-page (Copy 2)

- Page with photo;
- UK visa page (equivalent of UK residence permit).

#### □ Proof that the relationship is stable and durable (Original, Copy)





### □ Travel Insurance (Original, Copy)

#### □ Proof of sufficient personal funds (Original, Copy)

• to cover the cost of the trip or a sponsorship form legalised (Annexe 3Bis).

□ Copy of the identity card for the EU citizen or a copy of his/her residence card in Belgium (Copy 2)

#### □ Literal copy of your birth certificate for both of you (Copy 2)

#### □ Certificate of celibacy for both of you (Original, Copy)

Additional documents, even if not featured in the list above, may be required by the Embassy. The applicant is hereby informed that submitting the above-mentioned documents does not guarantee automatic issuance of a visa.

**IMPORTANT REMARK:** Guarantees for return (assessment of migration risk): the applicant is requested to provide as much information as possible to document his/her family background, professional and socio-economic status, ownership of land or real estate (for instance: proof of family bonds with his/her country of origin, proof of regular income and stable source of revenues from the applicant and/or his/her partner, proof of property, etc.).

This information is essential to correctly judge the intention of the applicant to leave the Schengen area before the expiry of his/her visa.
