WORKING HOLIDAY

Long stay working holiday (more than 90 days)

All documents submitted must be in English, French, Dutch or German.

The foreign official documents must be legalized or carry an apostil, unless an exemption is provided in a treaty.

All the relevant information on this formality is available on the website of the SPF Foreign Affairs.

Please note that you will need to separate 2 identical sets of documents (if documents are double sided, make sure you provide the photocopy of both sides).

To be able to apply for a working holiday visa in the United Kingdom, you must be Australian, New-Zealander or Taiwanese and you must be aged 18 to 30 years old.

MANDATORY DOCUMENTS

☐ Two duly completed and both signed VisaOnWeb application forms (2 signed copies)
The VisaOnWeb form with the bar code is available once the registration via <u>VisaOnWeb</u> is completed.
Please note that will be the only application form accepted.
☐ Four (4) ID photos meeting the ICAO standards

- Attached with a paper clip; In color;
- Size 3.5cm X 4.5cm;
- White plain background;
- Less than 3 months old.

- A travel document where a visa can be issued with a minimum validity of 12 months (e.g.: a passport);
- With at least 2 blank pages (side by side);
- Not older than 10 years old from the first issue date.

☐ Pro	of of payment for the <u>contribution</u> to the Ministry (Original, Copy) (If required)
☐ Pass	sport bio-page (Original, Copy)
•	Original and Copy of the Passport bio-page;
•	UK visa page (equivalent of UK residence permit).

☐ Proof of sufficient funds (Original, Copy)

Proof of sufficient funds to cover the cost for the first 3 months of the trip, at least 2 500 EUR.

☐ Certificate of good conduct (Original and Copy)

If you are 18 years old and over, your original certificate of good conduct covering at least the last year. It must also be <u>legalized</u>.

Please note that one can't submit an DBS certificate in lieu of an ACRO/Police Certificate.

☐ Original medical certificate (Original, Copy)

(unless it was submitted already to the Belgian authorities then a photocopy) by a medical practitioner approved by the Belgian Embassy, London;

☐ Proof that you have a medical and travel insurance (Original, Copy)

Which covers all medical and hospital costs, repatriation.

☐ Your ticket (Original, Copy)

- Your ticket to leave Belgium;
- Or the proof you have the means to buy one i.e copy of your credit card.

Additional documents, even if not featured in the list above, may be required by the Embassy. The applicant is hereby informed that submitting the above-mentioned documents does not guarantee automatic issuance of a visa.





IMPORTANT REMARK: Guarantees for return (assessment of migration risk): the applicant is requested to provide as much information as possible to document his/her family background, professional and socio-economic status, ownership of land or real estate (for instance: proof of family bonds with his/her country of origin, proof of regular income and stable source of revenues from the applicant and/or his/her partner, proof of property, etc.).

This information is essential to correctly judge the intention of the applicant to leave the Schengen area before the expiry of his/her visa.
