### LIST OF DOCUMENTS

## FAMILY REUNIFICATION WITH FOREIGN CITIZEN(MORE THAN 90 DAYS)

- You wish to go to Italy for a **long stay family reunification with foreign citizen relatives** for more than 90 days; you will need to provide **Nulla Osta "SUI"** and your name should be mentioned on the Italian embassy 's in Lebanon list for family reunification (contact us to check)

All documents must be translated into Italian only.

## **GENERAL DOCUMENTS FOR ALL APPLICANTS**

### □ Two long stay national visa application forms

Two <u>long stay national visa application forms</u> duly completed and signed by the applicant (or the legal guardian for minors) in the signature box at the bottom of the third page, original.

Note: it is more preferable that you provide the application form typed and printed out rather than filled by hand.

### □ Three identical ID photos

Size 3.5 cm x 4.5 cm, with white background, taken within 3 months and meeting set standards.

### □ Passport

- Original: A full national private passport or official travel document valid for at least 15 months after the day you plan to leave your country of origin, with two blank visa pages with the mention "visa" to affix the visa sticker. Should be issued in less than 9 years and 9 months after the expiry date of your requested Schengen visa. The photo used on the passport must resemble its holder at the time of submitting the file.

- Copy: one copy of the passport page containing personal identity information, one copy of the page containing the validity extension information, and **all the pages which contain Schengen visas issued during the last 10 years with all the stamps**.

### □ Resident Permit

- A copy of a valid resident permit beyond the return date from the Schengen area for foreign applicants residing in Lebanon or in Syria.





#### □ Proof of entry to the Lebanese territory

- This document can be a photocopy of the stamp on the passport or photocopy of the white entry card if you cross the border with your ID.

#### □ Family Statement legalized from the Italian Embassy

- Original +copy: This document should be issued within the last 3 months and legalized from the Italian embassy directly if the translation was done by a sworn translator accredited by the Italian embassy in Lebanon (click here to see the list).

- sworn translator in not accredited by the Italian embassy in Lebanon, the translation should be legalized from a notary, ministry of foreign affairs, ministry of justice with an English or French stamps before being legalized from the Italian embassy.

- For the reunification of a parent with a child residing in Italy only: the applicant (parent) must state the country of residence of each child showing on the family statement

Nulla Osta "SUI"

- this document should not be issued in more than 6 months from the date of the file submission and your name should be mentioned on the Italian embassy 's in Lebanon list for family reunification (contact us to check)
- □ Copy of the resident permit of the inviting person (plus proof of the resident permit renewal in case of expiration)
