ALL DOCUMENTS MUST BE CERTIFIED WITH AN APOSTILLE

IMPORTANT! Prepare one legible copy of each document separately in the same order (additional set)

International birth certificate form A (with apostille)

- o Original, not older than 6 months, issued by the Turkish Civil Registry Office (Nüfus Müdürlüğü)

Detailed family register extract (with apostille)

- o Original, current document issued by the Turkish Civil Registry Office (Nüfus Müdürlüğü)
- o All civil status entries and family relationships must be visible

Translation from the detailed family register extract

- o Original, translated into a Swiss national language (German, French or Italian) by a sworn translator
- o Please do not have it certified by a public notary

If the parents are divorced, divorce certificate with date of legal effect (with apostille)

- o An original copy certified by the court (Aslı gibi nüshası)
- o The document must be signed and stamped with the original court stamp
- o It must be clear which parent has been awarded custody

If the parents are divorced translation from the divorce certificate with date of legal effect

- o Original, translated into a Swiss national language (German, French or Italian) by a sworn translator
- o Please do not have it certified by a public notary

If one parent is deceased, International Death Certificate Form C (with Apostille)

- o Original, not older than 6 months, issued by the Turkish Civil Registry Office (Nüfus Müdürlüğü)

Declaration of consent from the parent who will not be travelling together with the child (Muvafakatname)

- o Original, current document issued by a public notary

Translation of declaration of consent from the parent who will not be travelling together with the child

- o Original, translated into a Swiss national language (German, French or Italian) by a sworn translator
- o Please do not have it certified by a public notary

From the family member living in Switzerland

- o Copy of valid passport or identity card
- o Copy of valid residence permit if family member is not a Swiss citizen

Visa fee: Payment: Only in Turkish currency and cash

- o Child, 6 -12 years: 40.- €
- o Child, 0 - 6 years: 0.- €
