Applicants must submit the application in person.	
The Consulate General of Switzerland reserves the right not to accept incomplete dossiers.	
No electronically issued (online) documents will be accepted.	
The application for employment purposes is sent to the responsible migration authority in Switzerland, which is responsible for approving the application. The Consulate General of Switzerland can only issue the Visa D after receiving the authorization of the migration authorities.	
A waiting period of at least 8-10 weeks must be expected (even longer, depending on the situation and the authorities).
